**ARTICLE VIII - CAPITAL CONTRIBUTIONS**


The members of the company shall contribute to the capital of the company.

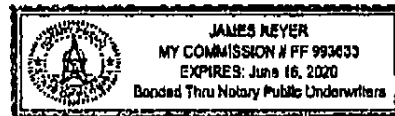


