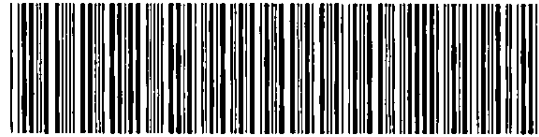

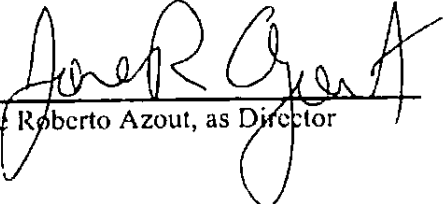
ARTICLES OF DOMESTICATION

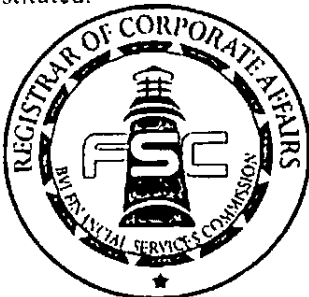
