ARTICLES OF ORGANIZATION

<u>OF</u>

WHOLESOME LEARNING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act. F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be WHOLESOME LEARNING, LLC. The street address of the principal office of the limited liability company in Florida shall be 13309 McIntosh Road.
