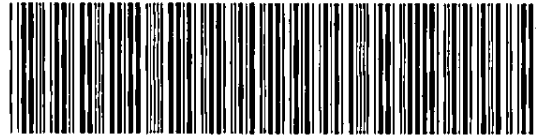

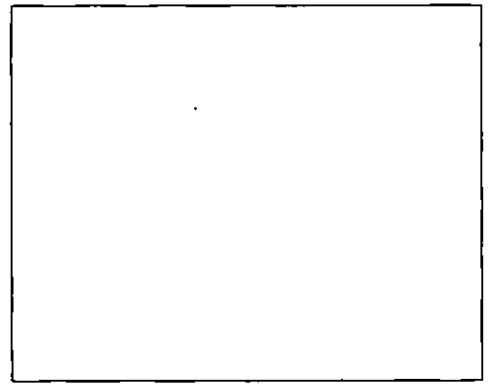

**ARTICLES OF ORGANIZATION OF**

**ARTICLE I**  
**NAME**
