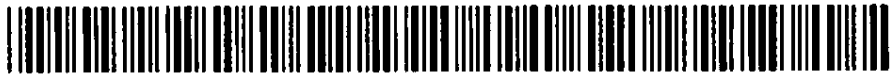


ARTICLE III

OTHER PROVISIONS


