**ARTICLES OF ORGANIZATION  
OF  
GIRASOL HOME, LLC**

1. Name. The name of this limited liability company is **GIRASOL HOME, LLC** (the "**Company**"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida (the "**Act**").

2. Duration. The **Company's** existence shall be perpetual, and the effective date of commencement of the **Company's** existence shall be July 14, 2017.

3. Purpose. The **Company** is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing and street address of the **Company's** principal office is 2550 Lake Ellen Drive, Tampa, FL 33618.

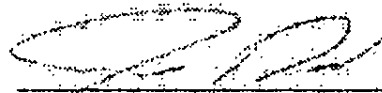
