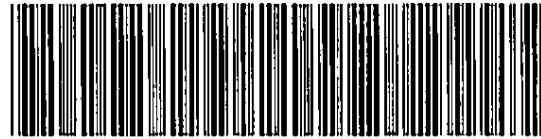

**ARTICLE VI. DISSOLUTION:** Upon dissolution, assets shall be distributed by the members according to the applicable statute. Further provisions regarding distribution upon dissolution shall be stated in the LLC Operating Agreement.

**ARTICLE VII. INDEMNIFICATION:** The LLC indemnifies any director, officers, employees, incorporators and members of the LLC from any liability regarding the LLC and the business of the LLC, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the LLC, or as otherwise provided under applicable state corporate statute.

**ARTICLE VIII. PROFITS AND LOSSES:** Members in the LLC shall share in profits, losses in proportion to their ownership in the LLC. Responsibilities and managing decisions shall be assigned by the members as they see appropriate.

**ARTICLE IX. TERMINATION, NEW MEMBERS.** The Members of the LLC, by their unanimous vote or consent, may terminate the LLC. Before any ownership can be transferred to any person by a member due to death, retirement, resignation, expulsion, bankruptcy or dissolution of the LLC, the LLC shall have the first right of refusal to acquire such share, followed by existing members or Directors.

**ARTICLE X. LIABILITY LIMITATION.** None of the Executives or members of the LLC shall be liable for payment of any debt, obligation or other liability of the LLC.

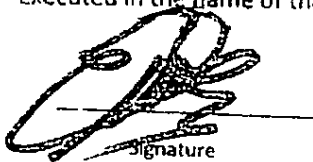
