Address

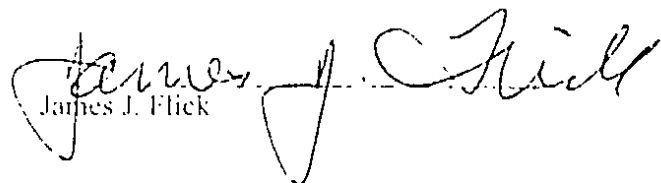

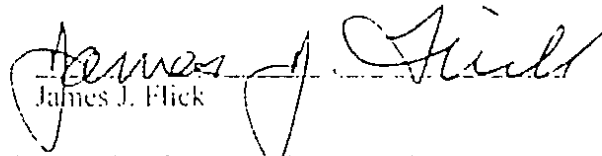
