



ARTICLES OF ORGANIZATION OF CERTUS VIE MGR LLC

The undersigned, an authorized representative of a prospective member, desiring to form a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby adopts the following Articles of Organization:

ARTICLE 1 - NAME

The name of the limited liability company is CERTUS VIE MGR LLC (the "Company

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

ARTICLE VI - INDEMNIFICATION

The Company shall indemnify any person who is or was a party to any proceeding by reason of the fact that such person is or was a manager, member or officer of the Company or its subsidiaries, to the fullest extent not prohibited by law, for actions taken in the capacity of such person as a manager, member or officer of the Company or its subsidiaries.
