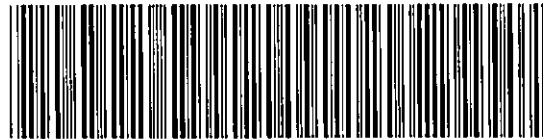

**ARTICLES OF ORGANIZATION
OF
SMIT RETIREMENT FUND, LLC**

The undersigned, MIKE GALVIN, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 605.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be SMIT RETIREMENT FUND, LLC

**ARTICLE II.
TERM OF EXISTENCE**

The initial registered agent of the limited liability company shall be the following named person at the following address:

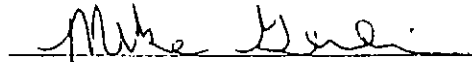

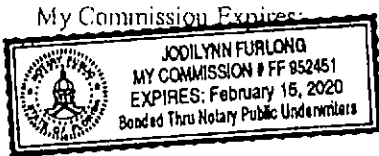

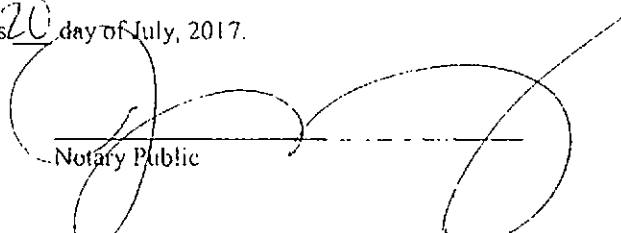
