**ARTICLES OF ORGANIZATION

The undersigned, Lamon May, a natural person competent to contract and an authorized representative of MAY BEAR CONSTRUCTION, LLC, hereby presents these Articles of Organization as the Articles of Organization of MAY BEAR CONSTRUCTION, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**



The Company shall be managed by a manager in accordance with the terms of the Operating Agreement for the Company. The names of the initial managers of the Company are as follows:


