**ARTICLES OF ORGANIZATION
OF

The undersigned, Jana Dawson, a natural person competent to contract and an authorized representative of Legacy RadChem Consulting, LLC, hereby presents these Articles of Organization as the Articles of Organization of Legacy RadChem Consulting, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME
