ARTICLES OF ORGANIZATION OF DESIGNERS CONCEPT, LLC

Under the Florida Limited Liability Company Act

ARTICLE I

The purpose of the Company is to engage in any lawful act or activity for which a limited liability company may be organized under the Plorida Limited Liability Company Act, as amended from time to time.
