## ARTICLES OF ORGANIZATION

## ADVENT TECHNOLOGY, LLC

The undersigned, acting as organizer and authorized representative of a limited liability company under the provisions of the Florida Limited Liability Company Act, as amended, Florida Statute 605 (the "Act"), adopts the following articles of organization for such company:

<u>Article I – Name</u>: The name of the limited liability company is ADVENT Technology, LLC (referred to below as the "limited liability company" or the "company").
