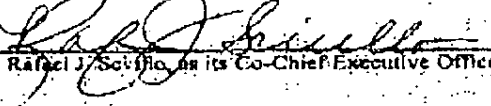
1. The name of the limited liability company is: **PONTUS HEALTH SERVICES, LLC** (the "Company").
