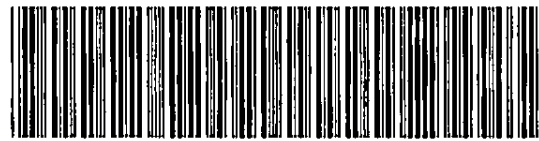

ARTICLES OF ORGANIZATION

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 – NAME**

The name of the limited liability company shall be ADVANCETEK INTEGRATED FIRE & SECURITY, LLC ("Company").

**ARTICLE 2 – ADDRESS**

The principle place of business of the company in Florida shall be 2927 Top Water Way, Kissimmee, Florida, 34746 and the mailing address shall be the same.

**ARTICLE 3 – EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE 4 – DURATION**
