The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act ("Act"), does hereby adopt the following Articles of Organization for such company.

ARTICLE I  
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is SOLAR PARK GAINESVILLE, LLC.

ARTICLE II  
ADDRESS

The Company's street address of its principal place of business in Florida is 120 120 Chiefs Way, Suite 1, PMB#222. Pensacola, Florida 32507, and its mailing address is 120 Chiefs Way, Suite 1, PMB#222. Pensacola, Florida 32507, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III  
MANAGEMENT

The business of the Company shall be managed by one or more Managers selected by the Members. The initial Manager shall be LAURA J. TYSON, at 1-9 Robert-Koch Strss, Polch 56751 Germany, who shall serve as the Manager of the Company until her resignation, or as otherwise provide in the Operating Agreement of the Company.

ARTICLE IV  
RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members and the Manager.

ARTICLE V  
OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the members unless vested in the manager of the Company by any amendments of the Articles of Organization. An Operating Agreement adopted by the members or by the manager may be repealed or altered, new operating agreement may be adopted by the members, and the members may prescribe in any operating agreement made by them that such operating agreement may not be altered, amended or repealed by the manager.

ARTICLE VI  
AMENDMENT TO ARTICLES

Any amendments to these Articles of Organization shall be in such form required by the Act and shall require the written consent of all Members of the Company. No Member shall have any vested right pursuant to these Articles that cannot be removed by amendment of these Articles. Each of the Members shall enter into an Operating Agreement for the Company containing such terms and conditions as are agreed upon by the Members.


