**ARTICLE I: NAME**

The name of the Limited Liability Company is **MORRISON AGRICULTURAL SERVICES, LLC**.


**ARTICLE II: MAILING ADDRESS AND STREET ADDRESS**

**ARTICLE IV: MANAGEMENT AND CONTROL**

The name and address of the member authorized to manage and control **MORRISON AGRICULTURAL SERVICES, LLC** is **WILLIAM F. MORRISON, JR., (AMBR)**, 10 State Road 544, Haines City, Florida 33845.

## **ARTICLE V: EFFECTIVE DATE**

The effective date of **MORRISON AGRICULTURAL SERVICES, LLC** is the date of the filing of these **ARTICLES OF ORGANIZATION** with the **SECRETARY OF STATE OF THE STATE OF FLORIDA**.

## **ARTICLE VI: MEMBERSHIP**

The sole and initial member of **MORRISON AGRICULTURAL SERVICES, LLC**, is **WILLIAM F. MORRISON, JR.**. The Company may admit new Members (or transferees of any interests of existing members) into the Company by the unanimous vote or consent of the Member(s). Upon such time as a new member is admitted, the Company shall adopt an Operating Agreement outlining the duties, responsibilities and obligations of each as it relates to Company business.

## **ARTICLE VII: MANAGEMENT**

**MORRISON AGRICULTURAL SERVICES, LLC** shall be a Single-Member Limited Liability Company, conducted and managed by the Member in accordance with this Agreement and the laws of the State of Florida.

The member shall have sole authority and power to act for or on behalf of the Company, to do any act that would be binding on the Company, or incur any expenditures on behalf of the Company. However, the Member shall have the power to delegate Company responsibilities, tasks and functions to other persons, especially to Donna Richardson, as he shall from time to time consider necessary, prudent or convenient.

The Member shall not be liable for the debts, obligations or liabilities of the Company, including under a judgment, decree or order of a court. The Company is organized as a "member-managed" limited liability company. The Member is designated as the initial managing member.

Except as limited by the Statutes, the Member may engage in other business ventures of any nature, including, without limitation by specification, the ownership of another business similar to that operated by the Company. The Company shall not have any right or interest in any such independent ventures or to the income and profits derived therefrom.

## ARTICLE VIII: OWNERSHIP of COMPANY PROPERTY

The Company's assets shall be deemed owned by the Company as an entity, and the Member shall have no ownership interest in such assets or any portion thereof.

## ARTICLE IX: INITIAL CAPITALIZATION


The Member shall initially capitalize **MORRISON AGRICULTURAL SERVICES, LLC** with a contribution of equipment and other capital as may be required.

## ARTICLE X: PURPOSE

The purpose of **MORRISON AGRICULTURAL SERVICES, LLC** is land clearing, site work, agricultural maintenance and improvement, and all activities related thereto.
