ARTICLES OF ORGANIZATION

OF

The undersigned does hereby execute these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida:

ARTICLE 1

The name of the limited liability company shall be:

ARTICLE II PERIOD OF DURATION

The period of duration of the limited liability company shall be perpetual.



ARTICLE III PURPOSES

The limited liability company may engage in the transaction of any or all lawful business for which limited liability companies may be formed under the laws of the State of Florida.

ARTICLE IV ADDRESS AND PLACE OF BUSINESS
