## ARTICLES OF ORGANIZATION OF FLORIDA CRACKER PHOTOGRAPHY, LLC

The undersigned, pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

#### ARTICLE I - NAME

The name of the Company is FLORIDA CRACKER PHOTOGRAPHY, LLC.

#### ARTICLE II - DURATION

The duration of the Company is perpetual.

#### ARTICLE III - ADDRESS AND PLACE OF BUSINESS

The mailing address and street address of the principal place of the principal office of the Company in Florida is:

#### ARTICLE IV - PURPOSE

The purposes of the Company shall be to engage in the business of photography, and any business related thereto or useful in connection therewith, and any other lawful business purpose or activity permitted by the Florida Revised Limited Liability Company Act (the "Act").
