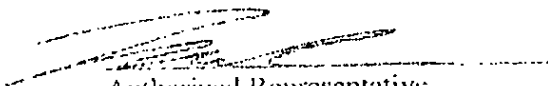
4. **Management of Company.** The company shall be a manager managed company and it shall have a single manager. The initial manager shall be:

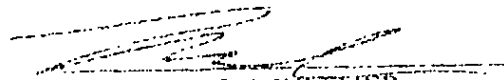
