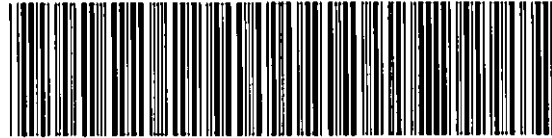

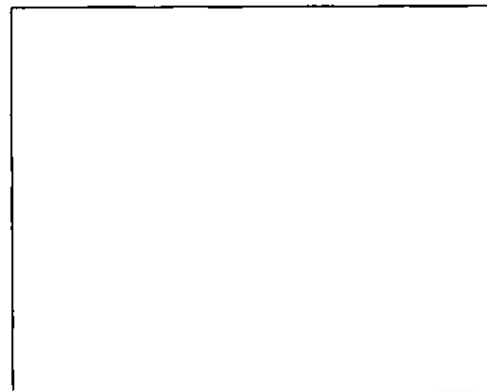

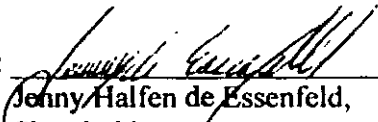

ARTICLES OF ORGANIZATION OF
SADIAM LLC

ARTICLE I
NAME
