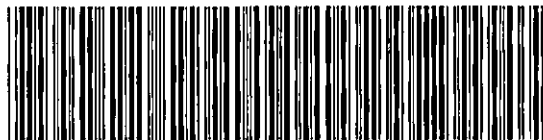

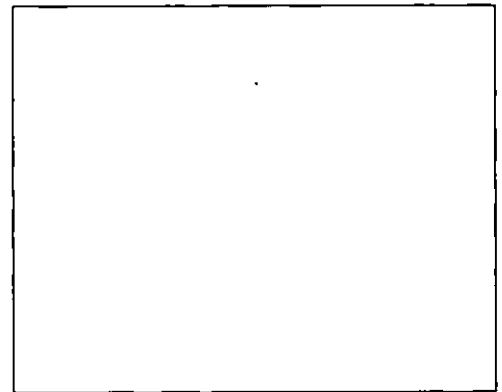

**ARTICLE I**


