**STATEMENT OF CORRECTION**

**ARTICLES OF ORGANIZATION**

The undersigned duly authorized representative of the members of **CCBL LLC**, a Florida limited liability company ("**Company**") formed under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby file this Statement of Correction pursuant to Section 605.0209, Florida Statutes, to correct an inaccuracy in the electronically filed Articles of Organization of Company, and states:

1. The Articles of Organization of Company were inaccurate at the time of filing on August 22, 2017 (Document #L17000179557).
2. The Articles of Organization of Company is to be corrected by this Statement of Correction.
3. The inaccuracy to be corrected is Article IV of the Articles of Organization, which incorrectly refers to four managers of Company when, in fact, there is only to be one manager: B Won, Inc.
4. To correct the inaccuracy, Article IV should read as follows:

**ARTICLE IV. MANAGEMENT**
