#### ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I

# NAME

The name of the limited liability company shall be WRIGHT FUNDING LLC ("Company").

#### ARTICLE II

#### ADDRESS

The Company shall be managed by managers in accordance with regulations adopted by the members for the management of the business and affairs of the Company. 
