ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

WHEREAS, the name of the company is PRESERVE SC MANAGER, LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on August 23, 2017 and assigned document number L17000180922; and

WHEREAS, the organizer has recommended the amendment to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its organizer and pursuant to the provisions of Section 605.0202 of the Florida Statutes, amends the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization is hereby deleted and replaced with the following:


ARTICLE IV  
MANAGEMENT

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company is Ethos Projects, LLC, which shall serve until replaced according to the provisions of the Company's Operating Agreement.

2. The date of the foregoing amendment's adoption was September 14, 2017.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
