## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION PRESERVE SC MANAGER, LLC

WHEREAS, the name of the company is PRESERVE SC MANAGER, LLC, a Florida limited liability company ("Company"); and
