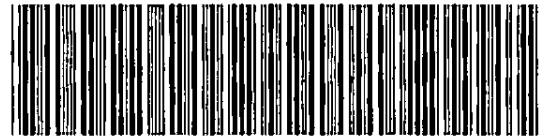

**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is John Deluca Medford LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The Company is organized for the purpose of purchasing, selling, leasing, investing in and managing real estate and transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 491 Bow Line Drive, Naples, Florida 34103.

8. Members of the Company. The name and address of the only member is:



10. Certificated Interests. The member's interests in the Company may but need not be evidenced by certificates.


