The name of this Company shall be **THEMED PONY PARTIES, LLC**

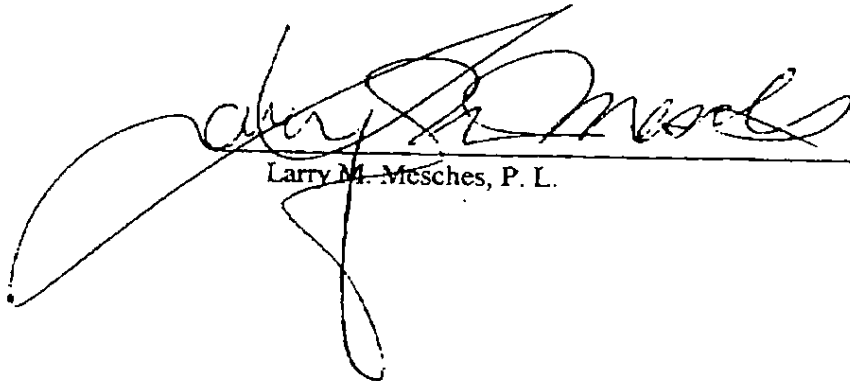
ARTICLE II

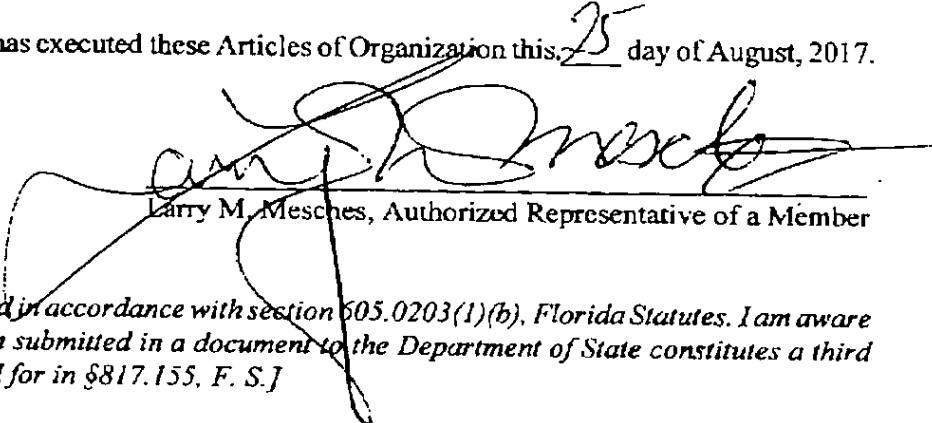
