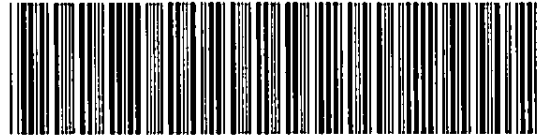

Pursuant to Chapter 621, Florida Professional Service Corporations and Limited Liability Company Act and Section 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the Sprofessional limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the professional limited liability company is Brent Johnson Law, PLLC (the "Company").

**ARTICLE II
PURPOSE**

The general purpose for which this professional limited liability company is organized shall be (i) to render legal services to the general public, and to do all things in connection therewith that are customarily done by lawyers under the laws of the State of Florida and (ii) in furtherance of its corporate purposes, the professional limited liability company shall have all of the general and specific powers and rights granted to and conferred on a company by the Professional Services Corporations and Limited Liability Company Act.

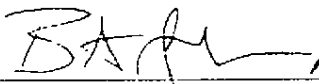
