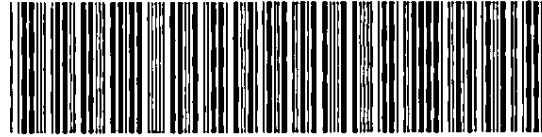

The name of this limited liability company shall be: **GLOBAL FAITH ASSET MANAGEMENT LLC**


ARTICLE II


