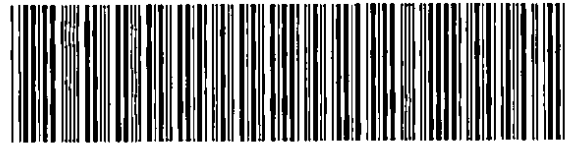

- FOURTH: A new Article VII is hereby added to the Articles of Organization to read as follows:

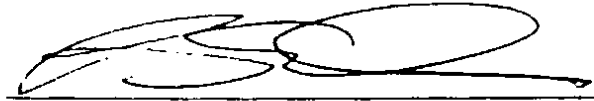
Article VII
