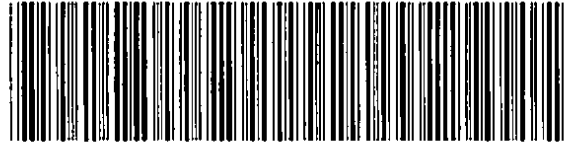

*The name of the limited liability company is **Williams Equine, LLC**.*

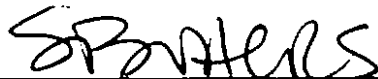
2. Article IV of the Articles of Organization is amended to read:

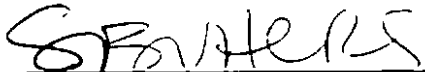
