**SECOND AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
MIAMI SEB LLC**

Miami SEB LLC, a limited liability company organized and existing under and by virtue of the provisions of the Florida Revised Limited Liability Company Act of the State of Florida does hereby certify:

1. That the name of this company is Miami SEB LLC, and that this company was originally organized with such name pursuant to the Florida Revised Limited Liability Company Act on September 21, 2017.

2. These Second Amended and Restated Articles of Organization were adopted by the members pursuant to Section 605.0202, Florida Statutes. Each amendment set forth in these Second Amended and Restated Articles of Organization was approved by the members by a vote sufficient for approval of the amendment. These Second Amended and Restated Articles supersede the initial Articles of Organization, as previously amended and restated by the Amended and Restated Articles of Organization filed with the Florida Secretary of State on January 9, 2018.

Resolved, that the initial Articles of Organization be amended and restated in its entirety to read as follows:



Article IV. Transferability of Membership Interests

No members shall have the right to assign their membership interests in the Company without the written agreement of all of the membership interests, unless otherwise provided in the Company's Operating Agreement. If the assignment is not approved by all of the membership interests, the assignee shall have no right to become a member, to participate in the management of the Company, or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.

Article V. Distribution of Profits

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of members who own more than 50% of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.


