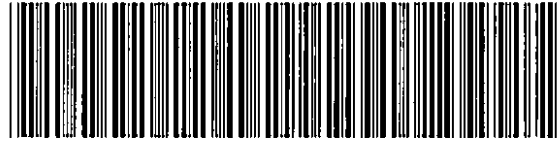

The Company's name is RE-NU Health Services LLC. The Company is manager-managed. The initial manager is Leon Flemembaum, M.D.


**ARTICLE II
