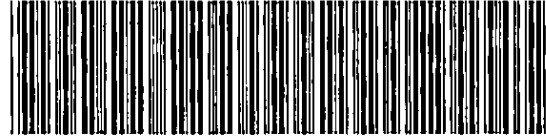



1. **Name.** The name of the Company is **Ronaldo Soccer Academy (Haines City), LLC.**


