ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
STANLEY 114 TURNER STREET, LLC

The undersigned, being an authorized representative of STANLEY 114 TURNER STREET, LLC, a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 605 Florida Statutes, hereby amends the Company's Articles of Organization as set forth below:

1. The name of the Company is Stanley 114 Turner Street, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State, effective September 25, 2017.
3. Article I of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE I.
NAME

The name of the Limited Liability Company shall be Turner Three, LLC."

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.

5. These Articles of Amendment have been approved by unanimous Written Action of the sole Member dated August 31, 2019, which vote is sufficient for approval.

6. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

The execution of these Articles of Amendment of the Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
