

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE WITH MINOR CHILDREN

THIS CAUSE came to be heard on August 6, 2020, upon the Petition for Dissolution of Marriage with Minor Children and Other Relief filed by Petitioner/Wife, CARMONA BESSEE-GIBBS (hereinafter referred to as the "Wife"). The Court, having reviewed the file and heard the testimony of the Wife, who was present via Zoom, FINDS as follows:

- 1. The Court has jurisdiction of the parties and the subject matter herein.
- 2. The parties have been residents of the State of Florida for at least six (6) months prior to the filing of the Petition for Dissolution of Marriage.
- 3. The parties were married on or about
- children, born of the marriage, to wit: 4. There are and and a whose date of birth children are contemplated, and the Wife is not expecting.
- 5. The marriage of the parties is irretrievably broken. Irreconcilable differences exist and have caused the breakdown of the marriage, and all efforts and hope of reconciliation would be impracticable and not in the best interests of the parties.
- 6. The Marital Settlement Agreement and Parenting Plan between the parties, introduced into evidence as Exhibit "1" have been filed herein and were executed voluntarily and after full disclosure. The Marital Settlement Agreement and Parenting Plan are approved and incorporated by reference, but not merged, into this Final Judgment and the parties are ordered to comply with all its terms.
- 8. The parties agree that the Wife shall be permitted to relocate with the

Riverview, Florida at any time after the conclusion of the 2019-2020 school year and this relocation is in the best interests of the minor children.

7. The Wife requests that her former name of

be restored.

IT IS, therefore, ORDERED and ADJUDGED as follows:

- A. The parties are awarded Judgment for Dissolution of Marriage, and the bonds of matrimony heretofore existing between DERON GIBBS and CARMONA BESSEE-GIBBS are hereby dissolved. The parties are restored to the status of being single.
- B. The Marital Settlement Agreement and Parenting Plan executed by the parties, introduced into evidence as Exhibit "1" and incorporated herein by reference for all purposes, is approved and expressly made a part of this Final Judgment for Dissolution of Marriage, and all of the terms and provisions of said Agreement are RATIFIED, CONFIRMED, and ADOPTED as Orders of this Court to the same extent and with the same force and effect as if its terms and provisions were set forth verbatim in this Final Judgment, and the parties are ORDERED to comply with the terms and provisions of said Agreement and Parenting Plan.
- C. Pursuant to the parties' Marital Settlement Agreement, the Husband shall pay directly to the Wife child support in the amount of per month, commencing on the first day of each month thereafter, for so long as the Husband has a child support obligation. Any deviation from the Child Support Guidelines was made in accordance with the children's best interests.
 - The Husband shall continue payment of child support for the children in such manner until modified by Court Order, and/or until the date of the earliest occurrence of one of the following events:
- (a) the child becomes emancipated;
- (b) the child marries;
- (c) the child dies;
- (d) the child enters military service; or
- (e) the child leaves the household or otherwise becomes self-supporting.
- D. The Wife's relocation to Riverview, Florida, is **GRANTED** based upon the parents signed written agreement which consents to the relocation; defines the access or time-sharing schedule for the parents and describes any post-relocation transportation arrangements relating to access or time-sharing. The Court finds that the relocation is in the best interests of the children based upon the Agreement.
 - E. Each party shall (a) provide to the other party any necessary information or to execute

and/or deliver any instrument or document necessary to transfer title or interest in property consistent with this Final Judgment or the Marital Settlement Agreement, and (b) timely perform such other acts that are reasonably necessary or that may be reasonably requested by the other party to effectuate the provisions of this Final Judgment or the Marital Settlement Agreement.

F. Any right, claim, demand or interest of the parties in and to the property of the other, whether real, personal or mixed, of whatever kind and nature and wherever situated, including but not limited to homestead, succession and inheritance arising out of the marital relationship existing between the parties hereto, except as expressly set forth or arising out of said Marital Settlement Agreement, is forever barred and terminated.

G. The Wife's former name of CARMONA DORETTA BESSEE is restored.

H. The Court expressly retains jurisdiction of this cause for the purposes of enforcing, construing, interpreting, or modifying the terms of this Final Judgment and the terms of the Marital Settlement Agreement and Parenting Plan entered by the parties herein.
