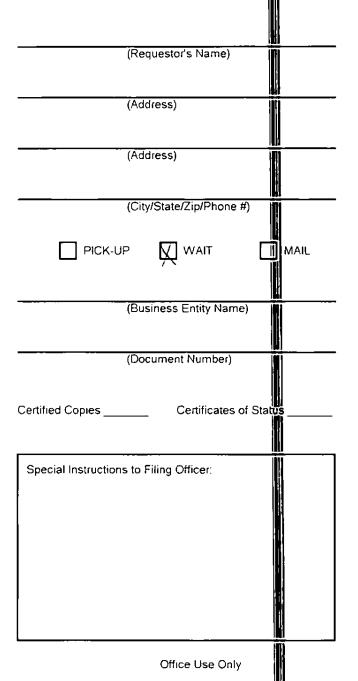

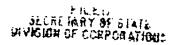

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF BH3 FL LLC

These Articles of Amendment are being filed pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act to amend the Articles of Organization of BH3 FL LLC, a Florida limited liability company (the "Company").
