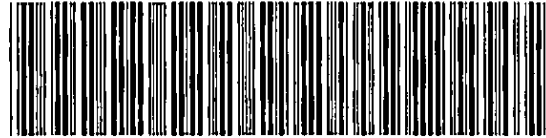

**ARTICLE III – MANAGEMENT**

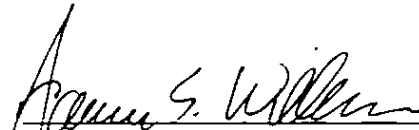

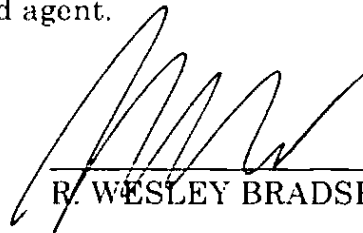
**CERTIFICATE OF DESIGNATION OF REGISTERED
