AMENDMENT TO ARTICLES OF ORGANIZATION

This First Amendment to Articles of Organization for ION LIVING NORTH MIAMI BEACH, LLC, a Florida limited liability company ("Company"), is made effective as of March 26<sup>th</sup> 2018, executed by ION LIVING NMB MEZZ, LLC, a Florida limited liability company.
