The undersigned, as the sole managers of GUBA WOLF, LLC, hereby execute and adopt the following Amended and Restated Articles of Organization.

**Article I
Name**

The name of the limited liability company ("Company") is **GUBA WOLF, LLC**.

**Article II
Address**

**Article III
Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

Members of the Company have the right to admit new members. 
