## ARTICLES OF ORGANIZATION FOR SERVICE DYNAMICS & INTEGRATION, LLC

#### **ARTICLE I - NAME**

The name of the Limited Liability Company is SERVICE DYNAMICS INTEGRATION, LLC.

#### ARTICLE II - ADDRESS

The mailing address of the Limited Liability Company is 7835 W. Commercial Blvd., Tamarac, FL 33351.

#### **ARTICLE III - DURATION**

The period of duration for the Limited Liability Company shall be perpetual.

#### **ARTICLE IV - MEMBER UNITS**

The Limited Liability Company is authorized to issue 100 Units of membership interest, which Units shall evidence the interest of the members of the Limited Liability Company, which Units shall be designated "Member Units." The interest of the members of the Limited Liability Company shall be evidenced by the Certificate of Limited Liability Company Units issued by the Limited Liability Company and setting forth the number of Member Units issued and outstanding in the name of such member.

#### **ARTICLE V - MANAGEMENT**

The number of members of the board of managers may be either increased or diminished from time to time as provided in the Regulations of the Limited Liability Company but shall never be less than one (1). Each manager shall serve until the first annual meeting of the members of the Limited Liability Company or until their successors are elected and qualify. #### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The managers shall hold those offices and have those responsibilities accorded to them by the members of the Limited Liability Company, as set forth in the Regulations of the Limited Liability Company.

#### ARTICLE IX - AMENDMENT OF ARTICLES OF ORGANIZATION

A majority of the members owning Member Units may consent to an amendment to the Articles of Organization.
