

ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statute, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be 2628 EDGEWATER, LLC, ("company").

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
