**ARTICLES OF ORGANIZATION  
OF  
ROGUE'S HAVYN PROPERTIES MANAGEMENT, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as the same may from time to time be amended, superseded or replaced (the "Act").

**ARTICLE I - NAME**

The name of this limited liability company (the "Company") is Rogue's Havyn Properties Management, LLC.

**ARTICLE II - ADDRESS**

The initial address of the principal office and the initial mailing address of the Company are 3211 Ferdinand Avenue, Tampa, Florida 33629.

**ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT**


**ARTICLE IV - MANAGEMENT OF THE COMPANY**


