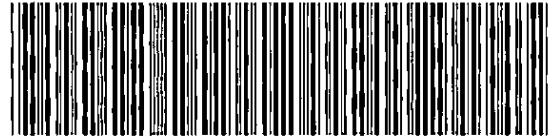

ARTICLE III - Management


The Company shall be managed by its member and is therefore a member-managed Company. The name of the some member of the Company is Miami A/I, LLC.
