ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
AIOAN STAFFING, LLC

The undersigned, being a Manager of AIOAN Staffing, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 605, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is AIOAN Staffing, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective October 4, 2017, and the Florida document number assigned to this Company is L17000205122.
3. Article 1 of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:
