The undersigned, Scott R. Kurfirst, a natural person competent to contract and an authorized representative of 34PNW, LLC, hereby presents these Articles of Organization as the Articles of Organization of 34PNW, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME


ARTICLE VI – MANAGEMENT


