**ARTICLES OF ORGANIZATION
OF

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I (NAME)

ARTICLE V (REGISTERED AGENT)


The name of the initial registered agent of the Company shall be Darrell Miller and the street address of the registered agent is 14 W. Jordan Street, Pensacola, FL 32501.

IN WITNESS WHEREOF, the undersigned, the authorized agent of a member, has executed the foregoing Articles of Organization on October 5, 2017.




