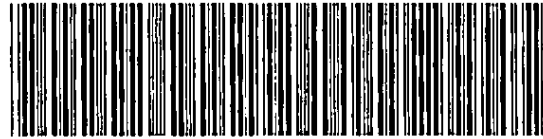

These are the Articles of Organization of the Company identified below. They are being filed with the Florida Department of State pursuant to Chapter 605, Florida Statutes for the purpose of creating a limited liability company.

**ARTICLE I - Company Name:** The name of the limited liability company ("Company") being created with these Articles of Organization is: Cursor Creative, LLC.

**ARTICLE II - Mailing Address:** The mailing address of this Company is 7650 NW 6th Court, Plantation, Florida 33324.

**ARTICLE III - Street Address:** The street address of the principal office of the Company is 7650 NW 6th Court, Plantation, Florida 33324

**ARTICLE IV - Registered Agent:** The registered agent and the street address of the registered agent of this Company in the State of Florida shall be:

**ARTICLE VI - Management:** The Company shall be managed by a "Manager". The initial Manager is Joseph Baum. In the event the Manager is either incapacitated or deceased the Company shall be managed by a "Successor Manager". The Successor Manager shall have no duties, authority or responsibilities until such time. The initial Successor Manager is Julia Poletti. The Manager and the Successor Manager can be replaced at any time by the consent of members holding more than 50 percent of the then-current percentage or other interest in the profits of the Company owned by all of its members.

**ARTICLE VI - No Personal Liability:** The sole member of the Company shall not be personally liable or responsible for any contracts, debts or defaults of the Company while acting for or on behalf of the Company in any official or authorized capacity.

**ARTICLE VII - Continuation of Business:** Unless dissolved in accordance with the Company's Operating Agreement, the remaining members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event

which terminates the continued membership of a member.
